**Item No 13.2: To Consider and approve the budget for the financial year 2021-2022.**


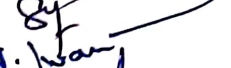


The budget was scrutinized by the committee and recommended to submit it in the Governing body.

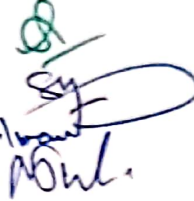
