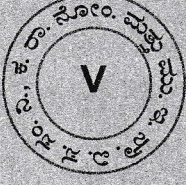

2.1 Role of SCET: Providing suitable infrastructure, students at your convenience.

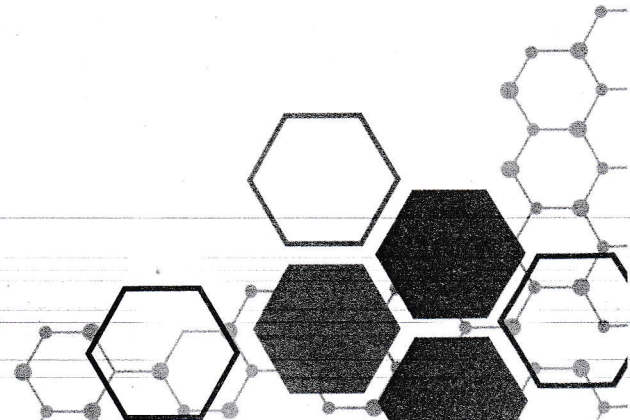

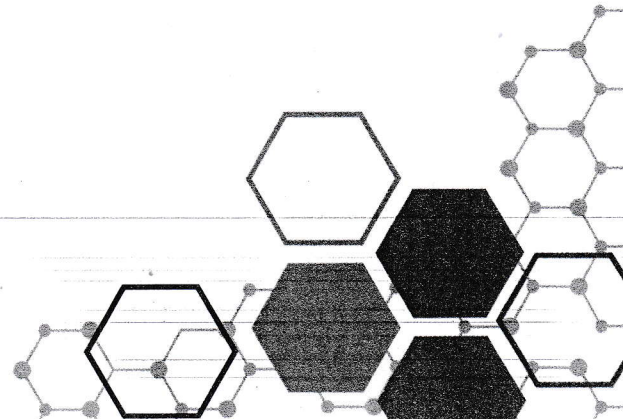

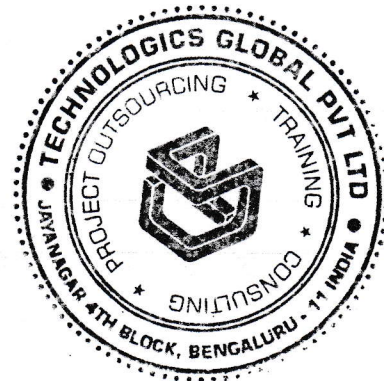
